Membership Dues

- **Nonworking membership:**

\$35 per month with no commitment of time working at VIA

\$90 per quarter with no commitment of time working at VIA

\$375 per year for 13 months with no commitment of time working at VIA

- **Working Membership**

\$20 per month with a minimum of 8 hours a month commitment working at VIA

\$50 per quarter with 8 hours a month commitment working at Vashon Intuitive Arts

\$185 per year for 13 months with a minimum of 8 hours per month commitment working at VIA

Member Benefits

- 10% discount on all items in e Retail shop
- Offer services and/or other products and creations which fit into the metaphysical classification of Vashon Intuitive Arts which will be okayed by Retail committee.
- Use of the event space for \$10 hr.
- Advanced notice of sales and events
- Bio information on the VIA website plus a link to your own website if you are a service provider.
- Display brochures and business cards.

Consignment Rates

- Members pay 20% to VIA for services
30% for retail items
- Non Members pay 30% to VIA for services
40% for retail items

Treatment Room or Reading Room

- Members 20% of daily income
- Nonmembers 30% of daily income

Meeting Room/Event space

- Members \$10 hr.
By Donation \$5 per hr. and 20% of daily income
- Non Members \$15 per hour
By Donation \$5 per hr. and 30% of daily income

NOTE: Rental of space must include set up and tear down time. Please be prepared to add that to your hourly rate.
