Members

Membership Costs

\$35 per month with no commitment of time working at VIA

\$20 per month with 8 hours per month commitment of working at VIA

\$100 per quarter with no commitment of time working at VIA

\$50 per quarter with 8 hours per month commitment of working at VIA

\$375 per year for 13 months with no commitment of time working at VIA

\$185 per year for 13 months with 8 hours per month commitment of working at VIA

Membership Benefits

Membership benefits include but are not limited to the following:

1. A 10% discount on all items and some events (**note this when you price your goods/services**)
2. The ability to offer my services and/or other products and creations
3. The ability to use the meeting space for classes etc. by paying 20% of gross as rent
4. The ability to check out books from the VIA library
5. Advanced notice of sales and events
6. Bio information on the VIA website plus a link to your own website (when available)
7. The ability to create a page for a biography binder with information about myself as well as display brochures and business cards
8. Sponsor an outside presenter with council approval
9. Offer my service in a divination card (for those who want to let the universe decide what they need)
10. Special rental rates for the Treatment Room and priority for space and reception services

Consignment Rates

Members pay 20% to VIA

NON Members pay 35% to VIA

Room Rental Rates

Treatment Room – Members

\$50 per day (8 hours) when reserved

\$30 per half day (4 hours) when reserved

20% of gross revenue when used as “walk-in” A walk-in would be when you are spending time in the space and someone walks in for a treatment rather than if you have a confirmed booking and need to rent the space.

Meeting Room – Members

20% of gross revenue

Meeting Room – NON Members

\$15 per hour

If an event by donation, 25% of gross revenue, room must be reserved

NOTE: Rental of space must include set up and tear down time. All fees are negotiable with the council, for members only, by event

Rights & Responsibilities

8. I will contribute to the whole as best I am able. I know that volunteering my time in the physical space is not mandatory but that it is encouraged. If other work obligations or physical condition prohibit this form of contribution, I will attempt to contribute in another way
9. I understand the VIA member and/or client list is not for personal use and I know that list, website or links is a privilege of membership only
10. I will provide proof of insurance and license if I am providing hands on services
